The immediate cause of physical harm in the US is repeated criminal medical negligence (at least 25 instances) in medical settings facilitated by criminal fraud of medical diagnostics (at least 20 instances) with the object of physical disability, immobility, or physical disfigurement.  
The social group would be "those with medical or neurodegenerative or medical conditions" (in my case Multiple Sclerosis and epilepsy).  
It is blanket discrimination in the US due to my neurological condition that goes well beyond medicine. Mis-portrayal in a social space, using the effects of the condition to effect a person negatively in an interpersonal space. Eg. Intentional isolation for several years at a time.  
~~Sexual discrimination using the effects of the condition as justification. This includes trying to impress sexual incongruity against personal standards and intentionally isolating me from all adult females in the US to restrict normal interpersonal relationships. I am heterosexual.~~  
Discrimination of basic livelihood using the effects of the mistreated neurological condition as justification. Most of the jobs I applied to (thousands of jobs) are below my qualification as engineer and IT professional with no response as a intentional national restriction; though I am extremely adept at my job tasks.  
General mis-typification of a person using the effects of the condition, I am called "odd" or "mentally deficient" (though I clearly have an IQ far greater the average person). The US cites nonsensical and irrelevant arguments to justify mistreatment in medical settings to intentionally effect social, professional, and interpersonal relationships.



If the reason why you are claiming asylum is not listed above, please state the reason or reasons below:

A more appropriate way of stating it is that the criminal fraud and negligence in the US with the object of causing physical harm, disfigurement, or immobility is for the sake of creating a reason for discrimination and persecution. Its to create a physically disfigured or intellectually inept person and thus limiting livelihood and social perseverance. Its to create a difficult to deal with or physically undesirable person through neurological damage. If the US caused enough neurological damage they could use the damage caused as a reason to limit social interaction, limit basic livelihood, or create a sentiment of "odd" or "unintelligent person". They are trying to change an atheist to a religious person by causing a dementia (people with dementias suffer from religiosity; its a neurological effect). Thus a claim based on religion. They are trying to create a social group of "medically disabled" by perpetuating intentional physical harm.

1. Why do you fear returning to your home country?

The US is aggressive about perpetuating criminal medical negligence domestically and abroad with the object of causing physical harm, disability, immobility, or physical disfigurement. There is an abundance of evidence to support this (detailed medical data and even videos of fraud being committed). The medical data to support this is included as supporting documents to this document (Titled: "Documents that Demonstrate Repeated Criminal Diagnostic Fraud and Criminal Negligence that Took Place in the US and Abroad"). There is a USB drive included with video data of crimes taking place in medical settings (eg. evidence of diagnosticians and clinicians hiding medical data in clinical settings). The documents are detailed and extensive to describe the criminality.

This perpetuated aggressiveness and clinical fraud has happened in Germany, Latvia, India, Mexico, and Thailand. More recently it happened in the United Kingdom resulting in a police case against two doctors here (crime incident # 2302885/20) reported on 27/01/2020. The doctor here tried to perpetuate the same type of criminal fraud that had taken place in the US and in other countries as directed by the United States. Recognizing it, I filed the appropriate complaint with the hospital and then filed a police report when the complaint was denied by the diagnostician and the hospital. The diagnostician refused to rescind the falsification with gross evidence so I had to file the police report in London.

I have repeatedly tried to gain the legal help (Document titled: "Lack of Legal Representation in the US") to report the crime in the United States or to report the crime through the US embassy in London and the representatives here simply ignore the case or don't respond. Its a perpetuated crime that is restricted in being reported in the United States.



The US remains persistent in trying to effect a US citizen in asylum in the UK (thus the police report) much like past instances when I was simply abroad. This validates my need for asylum and legal separation from the US; I must be protected specifically under asylum laws, which is why I applied for it. The US will not stop until they have cause physical disability or disfigurement by medical negligence as has been demonstrated in the past.

Beyond this there is daily intentional malice in the US based on character mis portrayal, sexual mis portrayal and discrimination, discrimination in basic livelihood, and general mis-typification of personality characteristics or level of intelligence (though I have a higher than average IQ). as described before.

The point is to persistently instigate any situation to exacerbate my neurological condition to make it harder to manage or to effect me in any space in a negative way. Thus I fear going back to the US.

## 2. Details of specific events which happened to you in your country that make you fear going home.

There is a list additive to this section that gives both a timeline and a listing of the number of instances that the medical condition was mistreated (both domestically and abroad). Titled "Instance by Instance list of Criminal Medical Fraud and Criminal Medical Negligence". The repetitive scenario is that in the US medical diagnostics are often falsified (criminal fraud) and using falsified documents medications/treatments for a progressive neurodegenerative condition is denied. This is with the intent of causing physical harm and avoiding legal consequence for past instances of medical negligence.

This listing is detailed with each instance having a more involved explanation in a separate document. The documents are in the section "Documents that Demonstrate the Repeated Criminal Diagnostic Fraud and Criminal Negligence that Took Place in the US and Abroad". The listing is a timeline that spans more than a decade (from 2007 to 2020). A timeline is included. This results in a non trivial criminal case.

Mistreating the condition equates to harming a person from the inside out (a form of medical bioterrorism) and leaving me in intense physical pain all the time (24/7 and years to a decade on end until medications were given outside the US). Since the condition causes inflammation in the spinal column (which controls physical sensation) the pain is equal to placing my limbs on a hot stove and leaving it there. Neuroanatomy and physiology dictates that effect. Its gross inhuman mistreatment to try and physically harm a person.

But the daily malice outside medicine in the United States adds to the fear of going back to the US. They are aggressive in intentional social isolation in the US. Discrimination in basic-livelihood, and restricting relationships with adult females is part of the daily malice that takes place in the US.

In settings abroad the diagnosticians are forced to falsify medical diagnostics to support the negligence in the US but still give some of the palliative medications eg. IV methylprednisolone and a few of the prescribed medications for relapse remitting multiple sclerosis. They feel that they are obligated to support the US in causing physical harm or disability or to protect the negligence that has taken place there (trying to protect the doctors that perpetuated malice and negligence in the US).

## 3. Details of what made you decide to leave.

When I initially decided to leave the US is before I left of asylum, it was to seek medical help after almost a decade of criminal medical mistreatment in 2015. The criminality of what had taken place was unknown to me then. There is a attached document titled "Number of Trips Made Abroad due to the Intentional Lack of Medical Help in the US Leading to Asylum" that describes why I left and the course of events leading to asylum. There were 23 different trips abroad (or to different countries) before I left for asylum in the UK. It describes why it cumulated to asylum and why its required.

The US denied help with criminally fraudulated diagnostic reports and medical documents in the past but with each trip abroad I would bring more diagnostics and ask for medical help for a gross medical pathology. The doctors in the US would once again write falsified reports and deny medical help (reports are criminal negligence again); there was no help in the US. I was in sever physical pain and having seizures from the gross criminal negligence that had taken place in the US, so I left to seek medical help abroad. They US doesn't understand that its inhumane to consider trying to cause harm through neurodegeneration of the spinal column or brain; it would leave the person in unbearable physical pain and leave a person with seizures.



The US didn't want to admit to past medical negligence and criminal fraud that had taken place over the decade earlier so they instructed medical professionals in foreign nations to perpetuate the same type of diagnostic fraud and medical negligence. After more than 12 instances of criminal medical fraud outside the US directed by the US it was determined that I would need asylum protection under refugee laws to protect me from US directed malice.

The US is always persistent when I am in the US, medical malice, social malice, living space malice, and work place malice. They directed foreign countries to perpetuate the same type of malice.

4. Details of any specific events in which you were personally involved that relate to your asylum claim.

Everything that led to asylum is described in the three documents "Instance by Instance list of Criminal Medical Fraud and Criminal Medical Negligence", "Documents that Demonstrate the Repeated Criminal Diagnostic Fraud and Criminal Negligence that Took Place in the US and Abroad", and "Number of Trips Made Abroad due to the Intentional Lack of Medical Help in the US Leading to Asylum". From January 2017 to Early 2019, there were at least 12 instances of clear medical need and a few medical emergencies warranting ER treatment completely ignored in the US. The US was most aggressive right before I left the United States.

For many asylees its risk of external harm in a physical war. In medical terrorism its internal harm, while hiding the medical pathology in trying to cause physical disability. The overall effect is the same, physical disability or physical disfigurement.

It would be fear of the medical doctors that perpetuated the medical negligence in the US and those leading the medical negligence with an objective goal (cause physical disability or create an intellectually inept person). The pattern of medical mistreatment was initiated by Dr. Richard Falzone in late 2007 and the pattern of medical negligence was initiated by Dr. Evan Murray in late 2008. Dr. Murray (neurologist) ignored a gross finding in a MRI series and report that required emergency treatment that was subsequently mistreated by Dr. Falzone.

All other medical falsification and negligence thereafter are predicated on the medical negligence and mistreatment that took place between 2007 to 2010 by these two doctors (and the other doctors during that period of time). This medical negligence caused a perpetuated syndrome of neurodegeneration along the brain and spine, epilepsy, and a dementia secondary to multiple sclerosis. This was intentional (unknown to me at that time).

Who I fear is all medical professionals in the US that participated in the medical malice and negligence listed in the document "Instance by Instance list of Criminal Medical Fraud and Criminal Medical Negligence". The US specific doctors are highlighted with stars in the listing along with their location and a detailed description of what each doctor did is given in "Documents that Demonstrate the Repeated Criminal Diagnostic Fraud and Criminal Negligence that Took Place in the US and Abroad".

6. Details of anything that happened to you en route to the UK.

After gathering my things for asylum I first flew to Japan on May 27th 2019 to consider applying for asylum there but the language barrier and wait time for asylum proceedings is considerable (2 years). So I decided on the United Kingdom. I first flew to New Delhi, India on July 11th 2019 to get IV Rituximab (medication for multiple sclerosis) to stabilize the condition before I came here (it temporarily delays progression of condition so I could wait for 6 months for this asylum proceeding).

The neurologists in India clearly typified the type of MS and the nature of its progression and why I specifically need the complex IV medications to slow the rate of the condition. The medications are grossly needed and either denied or hindered by the United States.

7. How you traveled to the UK from your home country.

I left the US on May 27th 2019 and flew to Japan, then I left Japan to New Delhi, India on July 11th 2019, and finally left New Delhi on July 23rd, 2019 to London, UK. I arrived in the UK on the 24th of July 2019. I immediately applied for asylum. The asylum intake took place on the 5th of August 2019.

8. Details of anything that has happened since you arrived in the UK which has made you afraid to return home.

The US tried to perpetuate the same type of criminal fraud in the UK. Falsifying medical documents in diagnostic tests to try and withhold medications for the condition. This was done in Queens Square, London (National Hospital for Neurology and Neurosurgery). The case is now a police case (case # 2302885/20) against diagnostician Dr. S. Catania and consultant Dr. Anand Trip.

The US is still aggressive in trying to perpetuate harm in a person that is in asylum in a foreign nation.

9. What you believe will happen to you if you return to your country of origin or the place where you were previously living.

Exemplified by past situations repeatedly explained in "Number of Trips Made Abroad due to the Intentional Lack of Medical Help in the US Leading to Asylum", they will replicate the same situations as in the past. They will ignore any medical evidence from any foreign nation and perpetuate malice in medical settings to try or cause harm in addition to malice in social settings. The goal is to try and further disease progression in multiple sclerosis to the point of disability or immobility.

The US will persist with no basis or reference to law. When I called the US embassy to report the crime they refused to respond and they wouldn't allow me to report the crime. The document "Lack of Legal Representation in the US" further explains this situation.

The time line included that shows the sequence of events for a visual portrayal. All the events of malice in medical settings are given in the document "Instance by Instance list of Criminal Medical Fraud and Criminal Medical Negligence" followed by "Documents that Demonstrate the Repeated Criminal Diagnostic Fraud and Criminal Negligence that Took Place in the US and Abroad". The presentation is detailed.

I grew up in Massachusetts, US and worked there till January 2017. Due to new job placement I moved to San Diego, CA from January 2017 to December 2018.

Due to the level of malice and persecution that has taken place in the US I tend to be in different countries either to seek medical help or to seek protection from harm. These countries include (by percentage of time spent) Latvia(Riga), Mexico(Tijuana and Mexico City), Thailand(Bangkok), Germany(Berlin and Munich), India(New Delhi), Japan(Tokyo and Hokkaido), Malaysia(Kuala Lumpur), Canada(Montreal), and Italy (Milan). I have been in each country intermittently for a period of several week to months.

Medical help was sought in all countries and hindered by the United States. The document "Number of Trips Made Abroad due to the Intentional Lack of Medical Help in the US Leading to Asylum" describes my residence in places outside the US, length of time there, the reason for being there, and how it led to asylum.

I have an undergraduate degree in Electrical Engineering from Pennsylvania State University, University Park, PA, USA (graduated in 2013). Afterwards I took additional classes in Boston University and Harvard University in business, marketing, electrical engineering and neurology (Harvard), respectively.

I have a neurodegenerative condition (Multiple Sclerosis) with all the appropriate diagnostics and reports to support it. The mistreatment of which is the reason of asylum.

The evidence of medical condition is in the printed documents under the section "Medical Documents, Diagnostics, and Clinical Reports from Treating Physicians in Comparison to and to Demonstrate the Clinical Fraud and Criminal Negligence in other Settings". The USB included with documents contains the medical data (including some diagnostic tests) from which the documents were written and the printed documents in a digital copy.

It's a progressive type of Multiple Sclerosis (that which will cause damage to the brain and spinal column unless medications are given consistently). It requires IV medications every 6 month (or sooner depending on medication) with the help of doctors abroad to reduce the progression but is hindered by the US, thus requiring asylum (cause of physical harm).

The second parcel includes the same printed PIQ response with printed supporting documents and is a much larger parcel to ensure delivery of the PIQ with supporting documents by 13/02/2020.



The supporting documents are listed below and organized according to title (they are all written in English):

"The Required Documents Section" includes:

Birth certificate

College record

Copy of US Passport (which you have)

Previous places of residence: Massachusetts and California Drivers licenses (will show original in interview)

Plane tickets to show travel route (from the US to Japan to India to the United Kingdom for Asylum)

In the following documents the original (medical) documents were digitized to make it easy to bring them abroad. Many documents were digital to begin with (there are thousands of documents so they must be digital to being abroad). They are formatted with explanations in each section to make it easy to understand them. All original digitized documents are available in high resolution files and available upon request.

"Number of Trips Made Abroad due to the Intentional Lack of Medical Help in the US Leading to Asylum" - It goes through the number of countries and trips made abroad and the events that took place in each country when seeking medical help due to the criminal malice in medicine taking place in the US. More then 23 trips (to different locations in the planet) eventually leading to asylum in the UK are described.

"Medical Documents, Diagnostic Data, and Clinical Reports from Treating Physicians" - Gives the medical documents (clinical summaries) and diagnostics of treating physicians who tried to stabilize the condition counter to the criminal fraud and negligence in this case.
