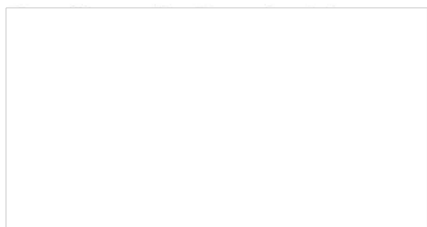

Background:

Multiple Sclerosis since clinical toxicological syndrome in 2008 and clear neurological signs before in 2007.

Nature of criminal malice and criminal medical negligence:

The role of criminal fraud is to further criminal negligence with an intent of causing physical harm, physical disfigurement, or physical disability in me.

The criminals feel that as long as they continue to accumulate medical falsifications (and often unrealistically and inappropriately) in a progressive neurodegenerative condition (that often requires hospitalization) they could be absolved of their past criminal negligence with further criminal falsifications (hiding past medical harm caused by falsifying future tests). The overall effect is that it caused progressive neurological damage to the optic nerves, brain, and spinal column (which is easy to demonstrate in MRIs).

Each instance of criminal fraud is an added instance of aiding and abetting a criminal to further negligence.

Their mindset is similar to common criminals, an attempt at avoidance of the illegality of criminal fraud by further perpetuating criminal fraud in another setting. They believe it's a convincing crime when it's easy to show otherwise.

Each instance of fraud, malice and negligence is typified in this list as what could only be described as unrealistic and easy to prove instances in malice attempts in medical settings.

A instance by instance list of criminal medical fraud and criminal medical negligence supported by fraud is given below (its non trivial criminal malice in a medical settings):

Doctors and diagnosticians in the United States are highlighted with a *.

1. *2008 April to 2010 October

▪ Dr. Richard Falzone – McLean's Hospital, Belmont, Massachusetts, USA

▪ Criminal Negligence →

▪ Negligence and mistreatment under psychiatry, future instances of medical mistreatment and negligence are predicated on Dr. Falzone and the next doctor, Dr. Evan Murray.

2. *2008 December 4th and 2009 February 5th

▪ Dr. Evan Murray - Belmont, Massachusetts, USA

▪ Criminal Negligence →

▪ 2008 December Gross Features of MS and metal toxicology present (in a MRI series) and ignored in a medical setting and intentionally left untreated; later found to be intentional.

▪ Dr. Evan Murray's negligence followed by Dr. Bruce Price's negligence (in the same hospital) with inappropriate recommendations that cause gross neurological damage, brain lesions and persistent seizures. The medical data for neurological damage or disease progression is attempted to be hidden there after (criminal fraud) in order to try and hide effect of negligence.

3. *2009 July 28th

▪ Dr. Bruce Price - Belmont, Massachusetts, USA

▪ Negligence

▪ Inappropriate recommendations that cause gross neurological damage, brain lesions and persistent seizures.

4. *2007 to 2011

▪ Dr. Gary Trey – Beth Israel Hospital, Boston, Massachusetts, USA

▪ Evasiveness

▪ Dr. Gary Trey was my primary care physician (GP) at Beth Israel Hospital. He either never wrote appointment summaries or erased them. Evasiveness.

5. *2009 April 8th April 10th and April 10th

▪ Mayo Clinic in Florida

▪ Dr. Gary Glicksteen and Dr. Elizabeth Shuster

▪ Clear Negligence and Probable fraud

▪ The clinicians ignore a gross feature of inflammation in the MRI and try to downplay the pathology. The clinician, Dr. Shuster hints that its multiple sclerosis in the report

(recommending a CSF test) but doesn't do the required tests

6. *2010 February, 22nd

- Beth Israel Hospital Radiology - Boston, Massachusetts, USA
 - Criminal Fraud →
 - MRI images are erased to hide MS with a fraudulated MRI report.

7. *2010 March 15th

- Dr. Ellen Salurand – UMass Memorial Hospital – Worcester, MA
 - Criminal Negligence →
 - Dr. Ellen Salurand denies treatment under toxicology with clear features in an MRI. All future MRIs show the toxicity that was attempted to be hidden in the February, 22nd MRI. Many future MRI reports are falsified.

8. *2010 August 25th

- Dr. Evan Murray and Dr. Steven Siner
 - Criminal Malice in a Medical Setting →
 - Giving ECT (a doctor knowingly giving a patient ECT (electro convulsion therapy) to a patient with multiple sclerosis that caused neurological damage and then recurrent seizures. Malice in a medical setting.

9. *2011 March, 10th

- Dr. Sundeep Kumar – Beth Israel Hospital – Boston, MA
 - Negligence →
 - Should have recognized that the previous MRI had missing MRI images in an incomplete series. An EEG was done in the hospital that may not reflect clinical presentation.

10. *2012 July 20th

- Dr. Brad Baker – Worcester, MA
 - Ignored clear optic neuropathy secondary to MS in high resolution images.

11. *2012 September 5th

- Dr. Joel Herskowitz
 - Negligence →
 - Failed to recognize the clear signs of MS and to do the appropriate tests. Later found to be intentional.

12. *2012 October 30th and December, 27th 2012

- Dr. Georgia Montouris - Boston Medical Center – Boston, MA
 - Criminal Fraud →
 - Fraudulated EEG and MRIs Reports under Dr. Georgia Montouris - Report it different from what the EEG and MRI shows.

13. *2013 October 10th

- Dr. Diana Apetauerova - in Lahey Hospital Massachusetts – Burlington Hospital
 - Fraud →
 - MRI Done in Lahey Hospital Massachusetts – Falsified Radiology Report. The spectroscopy shows clear deviations from normal in brain metabolism in the basal ganglia, her statements are false.

14. *2013 November 8th

- Dr. Stefanos Kales - Cambridge Health Alliance – Cambridge, Massachusetts
 - Criminal Negligence →
 - Replicates the same medical negligence as Dr. Ellen Salurand, denying treatment for a toxicological underpinning to a neurodegenerative condition.

15. *2013 November 13th

- Dr. Sean Rhyee – Umass Memorial – Marlborough, Massachusetts
 - Criminal Negligence →
 - Dr. Sean Rhyee is far more aggressive about limiting treatment under toxicology, all MRIs since 2008 show a T1 intensity in the basal ganglia of the brain indicating that the toxicity has been persistent since the first feature. It was an attempt under medicine to cause harm by limiting medical treatment for a clear condition.

16. *2014 July 29th to July 30th-Dr. Soujel Najjar and Kimberly Menzer-

- NYU Neurology- New York, New York, USA
 - Criminal Fraud and Negligence-
 - EEG report is falsified with clear evidence of seizures in the EEG.

17. *2014 June 17th

- NYU Neurology - Dr. Soujel Najjar and Kimberly Menzer – NYU Neurology- New York, New York, USA
 - Criminal Fraud and Negligence →
 - Extensive blood test reports and EEG reports are falsified in the hospital setting.

18. *2014 March 31st and June 5th – Dr. Valentine Riteri

- 2 appointments with NYC Psych Doctor where no medications are prescribed and Dr. Riteri isn't a treating physician

19. *2015 December to February 2016

- Dr. Vladan Milosavljevic - New England Neurological Associates – Lawrence, Massachusetts
 - Criminal Fraud and Negligence →
 - Fraudulates EEG and Blood Test. Fraudulence shown by EEGs done shortly thereafter in settings abroad.

- Dr. Maosong Qi
 - Possible Fraud
 - Possible fraud in blood tests.

20. 2016 to 2019

- Insurance Restriction
 - Using Insurance to limit affordability of medications for a progressive neurodegenerative condition. Medications for MS are required to be approved by US neurologists thus as long as they aren't approved US physicians could further physical harm to disability by restricting medications through insurance. I always have medical insurance in the US.

21. 2016 March 27th

- Under Dr. Yotin - Bangkok Hospital, Bangkok, Thailand -
 - Criminal Fraud →
 - Though Dr. Yotin is a treating physician the Lumbar Puncture results are falsified in the hospital. The falsification is easy to prove given that the EEG in the same hospital is a gross falsification with EEG video evidence to demonstrate falsification.

22. 2016 March 20th and 21st

- EEG in Bangkok Hospital - First and Second Day of Recording
 - Under Dr. Yotin - Bangkok Hospital, Bangkok, Thailand
 - Criminal Fraud – Falsified medical report that ignored medical data when the patient (me) has clear gross evidence of seizures during the EEG. The gross evidence of fraud substantiates that the lumbar puncture test is also fraudulented in the same hospital.

23. * July 25th 2016

- Dr. Jacob Sloan, Beth Israel Hospital, Boston, Massachusetts
 - Negligence →
 - 2016 asking For help in a serious condition- Dr. Sloan Denies treatment or diagnostics in Beth Israel Hospital with clear evidence of the clinical condition.

24. * 2016 July 7th

- Dr. Robert Fox, Cleveland Clinic, Cleveland, Ohio
 - Negligence →
 - Denies Treatment and Diagnostics in Cleveland, Ohio with clear evidence of the clinical condition.

25. 2017 January 10th

- Riga 1st Hospital Radiology – Riga Latvia
 - Criminal Fraud that shows all other MRIs are also Criminal Fraud →
 - MRI report is falsified with clear evidence of criminality. A high resolution video of technician is recorded which shows her trying to hide features of inflammation and neurodegeneration in the

26. *2017 April 7th and 2017 May 12th

- Dr. Paul Raffer – Sharp Hospital, San Diego, California
 - Criminal Negligence →
 - Dr. Raffer denies medical treatment for MS in Sharp San Diego with gross evidence and clear progression even after an ER emergency visit.

27. *2017 April 29th

- Emergency Department – Sharp Hospital – San Diego, California, USA
 - Negligence →
 - The ER department ignores clear optic neuropathy due to MS, no medications are given.

28. *2017 August 16th

- Emergency Department - University of California San Diego (UCSD) Hospital – San Diego, California, USA
 - Criminal Negligence →
 - ER denies treatment with a clear presentation and MRIs in a severe medical state warranting that I get the IV medications abroad immediately thereafter (in Mexico City, Mexico).

29. 2017 August 25th (Imagen Radiological), August 9th and 24th (Nucleo Radiológico Avanzado)

- Imagen Radiological Integral and Nucleo Radiológico Avanzado – Tijuana, Mexico
 - Criminal Fraud →
 - Imagen Radiological Integral - Radiology falsifies MRI Report- Gross features of neuroinflammation in the MRI make the report medically impossible. The radiology clinic in the future tries to erase evidence of the MRI altogether.

30. 2017 September 9th

- Dr. Miguel Balanzario - Hospital Angeles Acoxpa, Mexico City, Mexico
 - Criminal Fraud →
 - Hospital falsifies the Lumbar Puncture (LP) test as directed by the US.

31. 2017 September 25th onward till September 17th 2018

- CI3M Radiology Clinic – Mexico City, Mexico
 - Criminal Fraud →
 - Multiple instances of fraud in radiology reports (5 reports) that are a direct contrast to the progression of the clinical syndrome and course of medications. Reports ignore gross features. The treating neurologists in Mexico write reports that state the radiological abnormalities that the clinic tried to hide in fraudulent reports.

32. 2018 March 13th,

- Dr. Daniela Bermphol- Charity Hospital Berlin and Labor Berlin, Berlin, Germany
 - Criminal Fraud →
 - The doctor and the hospital falsify the results of a LP test that is immediately proven to be falsified. The results appear to be prefabricated and available within two days of the test (it requires 2 weeks for the results) and several ERs occur during the same time period followed by outpatient treatment due to severity of condition.

33. 2018 March 11th and March 16th to 17th

- Dr. Pia Schumacher, Dr. Benjamin Hotter, and Dr. Kaspar Streitberger, Charity Hospital Berlin (Virchow and Mitte), Berlin, Germany
 - Criminal Negligence →
 - Dr. Pia Schumacher and the other doctors deny medical treatment in a emergency setting for gross lesions and spinal atrophy clear in MRIs. Dr. Pia tries to state “disk degenerative disease” for progressive neural atrophy along the spine, which is absurd and medically impossible.

34. 2018 April 10th

- Dr. Patima Orrawanhanonthai - Bangkok Hospital, Bangkok, Thailand
 - Criminal Fraud →
 - Lumbar puncture tests results are falsified in a clear way with two subsequent tests showing gross optic neuropathy (requiring that the LP test have a positive for oligoclonal banding).

35. * 2018 June 14th

- Dr. Justin Dominick -Sharp Hospital San Diego, California
 - Criminal Negligence →
 - Lies about all MRI data shown to him in his report to further medical negligence with clear gross presentation of MS.

36. * 2018 July 16th

- Dr. Jonathan Carter - Mayo Clinic – Phoenix, Arizona
 - Criminal Negligence →
 - Dr. Jonathan Carter and Kate Grimsrud (Mayo Clinic Arizona) lie about MRI data shown to them and deny medical treatment.

37. 2018 August 15th and 28th

- Riga, Latvia - Riga 1st Hospital
 - Criminal Fraud
 - A radiology report of brain, spine, and thoracic is falsified in the hospital to perpetuate criminal fraud recorded before.

38. * 2018 September 19th

- Dr. Eric Williams – UCLA Hospital – Los Angeles, California

- Criminal Negligence →
 - Dr. Williams denies treatment for MS with clear gross features of MS in MRIs and other clear diagnostics.

39. * 2018 September 21st

- Dr. Philip Kinkle – UCSD- San Diego, California
 - Negligence →
 - Dr. Philip Kinkle tries to lie about the quality of optic neuropathy in his report and denies medical treatment

40. 2018 October 23rd

- Dr. Luis Enrique Amaya Sanchez - Hospital Angeles Pedregal, Mexico City, Mexico
 - Criminal Fraud →
 - The hospital falsifies the LP Test results though the doctor is a treating physician (he gives plasmapheresis in the same hospital). He mentions in his report that I have clear lesions in the corpus collosum (Dawson's fingers) and progressive MS making the LP impossible.

41. 2018 November 8th

- Dr. Elizabeth Soto Cabrera – Hospital Angeles Tijuana, Mexico
 - Criminal Fraud →
 - SEP test is falsified with erased values (amplitudes) and inappropriate interpretations. The graphs in the test show gross neurodegeneration in the cervical spine resulting in reduced sensation and movement in the left hemisphere of my physiology contrary to the statements made by Dr. Cabrera.

42. 2019 January 21st

- Dr. A. S. Arora – Apollo Hospital, New Delhi, India
 - Criminal Fraud →
 - Falsified radiology report and to an impossible extent (ignores all gross features in the MRI). Makes its clear that there is an intent to falsify medical data to hide a medical pathology.

43. 2019 April 17th

- Radio Imagen-Tijuana, Mexico
 - Criminal Fraud →
 - Radiologist falsifies a radiology report with gross features of neurodegeneration.

44. 2019 September 18th:

- Dr. S. Catania - The National Hospital for Neurology and Neurosurgery
 - London, UK
 - Fraud →
 - Falsified SEP (sensory evoked potential) tests in a medical setting with the intent of hiding the disease pathology around the neurodegenerative condition, multiple sclerosis, or to hide the

neurodegeneration that had taken place over more than a decade of malice in medical settings.

45. 2019 October 23rd:

- Dr. S. Anand Trip
 - The National Hospital for Neurology and Neurosurgery
 - London, UK
 - Support of fraud and medical falsification →
 - After Dr. Anand Trip made false statements with respect to MRI series that show gross features of Multiple Sclerosis in his office appointment he tries to support Dr. S. Catania in a falsified diagnostic test report.
